
## Is Your School EPA Asbestos AHERA Compliant?

Asbestos AHERA compliance for private schools have come to the forefront of EPA's inspections. The AHERA regulations were put into place to protect the public from asbestos exposure. Compliance with this regulation is required for all public and private K-12 schools. What does is take to be in compliance with this regulation? The following is a flow chart to determine if your school is currently in compliance with the AHERA regulations:

- 1. A completed AHERA asbestos inspection of all of the owned and leased school buildings.
- 2. If asbestos is present, a completed AHERA asbestos management plan.
  - a. Yearly parent/employee notifications
  - b. 3 year reinspections of the identified asbestos materials
  - c. 6-month periodic surveillance of the buildings that contain asbestos
  - d. Training records for asbestos awareness training for custodial staff

This Notice of Noncompliance (NON) is issued by the U. S. Environmental Protection Agency (EPA) Region 4 for violation of the Toxic Substance Control Act (TSCA) Subchapter II, Asbestos Hazard Emergency Response Act (AHERA), 15 U.S.C. § 2641 – 2656. On or about February 25, 2016, an inspector, authorized to conduct AHERA inspections on the EPA's behalf, conducted an AHERA compliance monitoring inspection of the above-referenced local education agency (LEA).	cc: Ms. Program Specialist Florida Department of Education
The EPA has determined that the above-referenced LEA is in violation of AHERA. The specific violations are identified in the enclosed summary of violations.	
AHERA, a provision of TSCA, became law in 1986. AHERA requires LEAs to inspect their schools for asbestos-containing building material and prepare management plans to prevent or reduce asbestos hazards. Public school districts, non-profit private schools and Department of Defense schools are LEAs and are subject to AHERA's requirements. This includes chatter schools and schools affiliated with religious institutions. The rules implementing AHERA are published in the Code of Federal Regulations, Chapter 40, Part 763, Subpart E. Information about asbestos in schools and the AHERA requirements can be found at www.epa.gov/asbestos/publis/asbestos in schools laml.	
EPA reserves the right to proceed with a formal enforcement action and seek civil penalties for these violations. Failure to correct any violation could result in the assessment of civil penalties up to \$7,500 per day of violation. At this time, the EPA Region 4 is offering the opportunity to correct the violations rather than proceeding with a formal enforcement action and seeking civil penalties. To take advantage of this offer, a signed statement must be sent to my attention at the letterhead address within 30 days of the receipt of this NON which certifies that all violations have been corrected. This statement must include supporting documentation that describes the action taken to correct the violation(s).
